

IMPORTANT CONSIDERATIONS REGARDING INDEPENDENT STUDIES

An Independent Study in THEATRST 291, THEATRST 291-1, or THEATRST 691 enables a student to pursue advanced inquiry into a field of special interest (acting, directing, playwriting/screenwriting, design/theater technology, dramatic literature, theater history, or performance studies) under the supervision of a faculty member. An Independent Study cannot duplicate available course offerings. However, please note that credit is granted in accordance with the student's declared School and Academic Plan, not by the Supervising Department, which may differ from that of the Student's Major, Minor, or other credit-granting governance, such other departments in Trinity College of Arts & Sciences, or schools in non-undergraduate careers such as The Graduate School, Pratt School of Engineering, or others. Limits apply to the number of Independent Studies that can be taken for credit in an undergraduate career, for example, so the student applying herein is strongly encouraged to consult with his/her/their advisor before committing to this or any Independent Study at Duke.

Courses entitled Independent Study are individual non-research directed study in a field of special interest on an approved topic taken under the supervision of a faculty member and resulting in an academic and/or artistic product.
